



# OVVI — Pricing & Sale Overview

This document provides a clear overview of OVVI token sale pricing, allocation limits, and launch parameters for transparency. It is provided for informational purposes only.

## 1) Token Summary

OVVI is a fixed-supply utility token on Solana (SPL standard) designed to support payments, incentives, rewards, and participation across OVVI digital products and platforms, including gaming modules. OVVI is a utility asset only and does not represent shares, ownership interests, or rights in any entity; it also does not provide profit-sharing or dividends. This document is separate from the White Paper and focuses strictly on token sale and launch figures.

## 2) Token Source for Sales

All tokens sold in the Private Sale and Public Presale come exclusively from the Initial Ecosystem Distribution allocation (34%) — 680,000,000 OVVI. No tokens from Liquidity Provisioning, Staking Rewards, Ecosystem Growth Fund, Burn Reserve, or Strategic Reserve are used for token sales.

## 3) Private Sale

**Platform:** Crypto Hub

**Price:** \$0.006 USD per OVVI

**Minimum target:** \$500,000 USD

**Target / Maximum cap:** \$1,000,000 USD

**Maximum allocation:** 250,000,000 OVVI (12.5% of total supply)

## 4) Public Presale

**Platform:** GemPad

**Price:** \$0.008 USD per OVVI

**Soft cap:** \$1,000,000 USD

**Hard cap:** \$2,500,000 USD

**Maximum allocation:** 420,000,000 OVVI (21.0% of total supply)

## 5) DEX Listing and Liquidity

**DEX listing:** Primary DEX Raydium (Solana). Liquidity routing/discovery via Jupiter integration.

**Initial listing price:** \$0.01 USD

**Liquidity funding target (at presale hard cap):** \$1,250,000 USD (50% of presale funds). If the presale completes below the hard cap, liquidity provisioning is adjusted proportionally based on actual funds allocated to liquidity.

**Estimated OVVI tokens for initial liquidity:** ~140,000,000 OVVI (based on \$0.01 listing price).

**Token source for liquidity:** Liquidity Provisioning allocation (10%) — 200,000,000 OVVI.

**Liquidity lock:** 12 months (LP lock).


